Thanks to all of you who continue to contribute to the SDHS Foundation, Inc. We have just finished an amazing year of financial assistance to students and for staff projects!

WE ARE IN NEED OF FUNDING!

We celebrated 86 brand new scholarship recipients and 30 student renewable scholarships from existing scholarships; totaling over \$200,000!

We are partnered now with a Baseball Boosters Club (helped finance new uniforms) and a Choir/Band/Orchestra Boosters Club made up of parents & friends of SDHS which collects money which goes directly to their club; an example of our support is that we financed our choir that was invited to sing with the band, Foreigner, at the Del Mar fair!

This year, in addition to amazing student scholarships, we contributed over \$55,00 to clubs and organizations; ASB's school wide Paper Chase, World's Faire and March Madness activities.

Support to other athletics include:UCSD student physicals, girls & boys baseball, basketball, wrestling, lacrosse, tennis,football and track & Field events.

With our help the Culinary Club was able to send (8) students to a special Chefs' convention in Italy and (20) Journalism/Yearbook students attended the annual Journalism conference which was held this year in Seattle Washington!

Science teachers provided us a comprehensive list of needs across the grade levels which we financed.

Staff appreciation Day was lively with a taco truck, gift cards and a piñata! Thank you Board members Amy Zheng & Vince Quitoriano for extra monetary support. Also we provided gift cards as incentives for students participating in the Wellness Center for Art Contests, Mentor Club & academic assistance; MedTech and Robotic Clubs were able to purchase club t-shirts this year with Foundation's support.

We continue to help finance college trips, have a newly formed Interact Club partnership with Rotary(thanks to our Charter Member Daryl Ferguson), Caver Closet by teacher Jaime Brown and donor Margret Green, students can 'anonymously' receive hygiene products, clothes, etc.; partnered with Alumni Association to reintroduce Caver Mascots: Bob & Betty!
